





# Scenario 1a

- Absolutely not! I pay taxes to have my kids go to Sunnyside! I moved to this house for this reason!
- Although we will no longer have students at Sunnyside next year, I feel that moving the Belmont Estates subdivision into the • Edgemont boundary is the most undesirable option, based on our kids' experiences & friendships.
- As a parent in Belmont Estates, we are a part of the COMMUNITY south of 49th. Taking our neighborhood and separating it from the other similar neighborhoods we moved here for feels like a bad
   decision for our students. Separating our neighborhood in this way will separate kids that have been together, and planning to attend school together since birth. Please leave Belmont Estates at Sunnyside!
- Belmont Estates should remain at Sunnyside and this plan does not result in that outcome. It is twice as far from Belmont Estates to Edgemont and will require parents to cross numerous busy intersections to pick up and drop off their children. This will lead to
   inefficiency and lost time that can and should be avoided. To put this burden on families of Belmont Estates is unacceptable.
- Belmont is now done building in the subdivision, so growth will be minimal aside from people moving in and out. It would be nice to keep those kids who began at Sunnyside and have established
   friendships at their school.
- Belmont neighborhood is closer to Sunnyside, our kids in this neighborhood also go to church with Sunterra and Avalon neighborhoods.
- Best utilization of both schools
- biggest concerns for me are that Sunnyside will remain overutilized and not room for future growth from the building in the south
- Build a south elementary. Makes it very inconvenient for our neighborhood to go to this location.

- Children's education and emotional well being are going to be disrupted due to school changes. I know this from experience. Find another solution that doesn't negatively affect the children.
- Classroom sizes are already large at Edgemont. There are currently new apartment complexes being built within the current boundaries that are going to fill Edgemont to capacity within the next 1-2 years. Adding Sunnyside students will cause even more overcrowding to happen.
- Create a new bond to address the elementary school need. Get rid of compass. Or at least use 1/2 the building for that. It is not being used as it was intended and put the 9th graders there. They do not need to be with grades 10-12. My 9th grader has changed dramatically this year. None of these options address the overcrowding of sunnyside or the growth. None of the options are feasible. Think outside the box! Don't try to fix everything at once. You started this whole process the wrong way.
- Doesn't relieve enough of the burden from sunnyside elementary.
   We will still be extremely overcrowded.
- Doesn't relieve the overcrowding at Sunnyside enough.
- doesn't address future growth of sunnyside
- Don't want to cut out Belmont.
- Easy to follow, clean boundary lines
- Edgemont needs room for growth.
- I am supportive of this option because it will not effect my family, however, I am not in favor of any of these changes because like many others I have chosen to live where I do mostly because of the schools my kids would attend.
- I am very nervous about the addition of nearly 100 more students to Edgemont. I feel like there are already problems at Edgemont bullying, running out of food at lunchtime, full classrooms, etc.

- I dislike that the area from 49th south to 65th is isolated to changing to edgemont. If boundaries were changing there I'd prefer it to include other close neighborhoods going to the same school so children that live close together are going to the same school to build relationships both at home and in school
- I do not want my children to be moved from Sunnyside. We live in the Sunterra/Yorkside Subdivision
- I don't think this scenario moves enough students. And it moves a group of students that are closer to the school which isn't fair. I personally think you should be redoing all the school boundaries
   for all the schools. Your boundaries make no sense in D91.
- I don't understand why you wouldn't move kids closer to Edgemont to Edgemont? Why would you take kids even further south of
   Sunnyside to a farther location??? South of Sunnyside should stay at Sunnyside.
- I don't want my children to go to edgemont. I bough a house in the 

   Sunnyside school boundary for a reason
- I dont like it, we moved to Belmont and heard so many excellent things about Sunnyside all of which are true, and now you want us
   to give that up.
- I feel like this scenario does not help Sunnyside or Edgemont in over-utilization and it does not help with potential growth
- I feel this is the best scenario. It doesn't push Edgemont over capacity and decreases capacity at Sunnyside. With all the new
   growth coming, Edgemont will be over capacity probably in 1 year and then what? Move the dunes neighborhood again to a different school? I just feel like The Dunes will be the ones having to be moved around a lot since we are on the edge of boundaries.
- I hope that when the boundaries are changed that it will be done in a way that plans for future growth. If this makes it so Edgemont will be okay with the growth that will occur by the development by Home Depot then this might be the best options. Just do what will allow the least changes in the future.

- I know families that have moved to those areas for Sunnyside and now would have to go to Edgemont. It would be hard.
- I like that it doesn't make two schools overcrowded but I do worry a little that it will be very temporary because of Sunnyside growth.
- I like that it expands the area closest to Edgemont into those boundaries.
- I like this better as my student would remain at sunnyside and not have to travel further for school everyday
- I like this option because I think it helps ease the strain on Sunnyside while not overburdening Edgemont. It affects fewer families as well.
- I love the class sizes at edgemont. I don't wish them to get any larger. We love edgemont and don't want our children to go anywhere else.
- I still don't understand why edgemont is in a checkerboard pattern - and what is the island to the west of Longfellow that is edgemont?
- I support this but I do not think it fixes over crowding for Sunnyside
- I think the dunes area should also be included in the change to edgemont. I think school boundaries should make sense geographically. Sunnyside's are MUCH too big. This scenario doesn't move enough kids to edgemont in my opinion.
- I think the move is too small. If a boundary change is made, it's better for the students if a big group moves all at once.
- I think this is the best option. It moves fewer students than other options while still better utilizing the schools. It leaves some room in Edgemont for future growth that will be coming from the apartments being built near Home Depot. Sunnyside is better able to handle the higher capacity due to the addition built to the school.
- I would hope that you have considered kids that are on waviers ie;

going to schools outside of where they should be going.. I think • we should not approve waviers except in VERY rare cases. Also the 9:00AM start time at Edgemont is a real problem for working parents and grandparents that are working so they cannot even help out with younger children.

- I would like scenario 1a to include the neighborhoods Shamrock
   Park and Cedar Ridge into Edgemont Garden Elementary. This would affect the boundaries of Longfellow Elementry school as well, however, it would create a more clear boundary for Edgemont Gardens, Elementary school, as well as eliminating the "islands" currently occurring in their boundaries. Both Shamrock Park
   neighborhood and Cedar Ridge neighborhood are within walking distance of Edgemont Gardens Elementry. This would eliminate busing from these neighborhoods to Longfellow Elementry. This would also allow for Longfellow elementary to now take the Sunnyside acres neighborhood away from Edgemont Gardens, this
   is more conducive seeing as how the Sunnyside acres neighborhood is currently surrounded by Longfellow boundaries.
- If it's not going to fix overcrowding at Sunnyside, why make a change? Don't change a broken thing to still make it so broken
- In all the scenarios, we never had the option of staying at 
   Sunnyside. Even though we are a lot closer in proximity than most
   of the people getting to stay at Sunnyside.

- It does not maximize Edgemont's capabilities, while allowing for potential future growth. Meanwhile Sunnyside Elementary is overwhelmed.
- It doesn't make any sense to move families that are closer to Sunnyside, but have families to the east of Belmont (that are further away from Sunnyside) keep going to Sunnyside.
- It doesn't positively impact the situation to just move some kids from Belmont and a few kids that live along 49th. It barely changes the utilization at Sunnyside.
- It doesn't seem to address Sunnyside's overutilization enough.

- It doesn't affect me, but I would like students to be moved out of Sunnyside boudaries.
- It doesn't relieve enough stress from Sunnyside.
- It seems to make the most logical sense of the three options.
- It would make more sense to send the kids to Longfellow elementary
- It would take my child away from Sunnyside, from his peer group, and put him in a slower pace learning environment
- It's odd that you would allow further schools away from Sunnyside school to still go there and move those to edgemont that are closer to Sunnyside school.
- It's tough, just need another school south.
- Keep adobe drive at sunnyside. I like that.
- Keep everything how it is!
- Leaves room for growth at edgemont
- Looks good!
- My child is on an aggressive IEP at Sunnyside she has two more years and a change would be highly disruptive to her learning
- My child will be in 6th grade next year. Would be nice for her to finish out with her friends. I understand why you guys need to do this though. Every possibility has us changing.
- My child would have to go to a different school then he has been in since kindergarten and Edgemont is very far in comparison.
- My children will have to travel farther to and from school everyday. Which increases the risk of an accident especially in the winter months. The roads surrounding Edgemont elementary are extremely narrow and during the winter undriveable. They would not be able to attend any after school activities as the school is way to far from our address.
- My concern is this doesn't really solve the problem of over-

crowding and if another elementary school is built several years • down the road will my kids then be moved to a 3rd school.

- My kids live 1 mile from there school. They will not go to a school 5 miles away. Build another school to accommodate this growing area
- My last child is a Sunnyside student. We stay in Sunnyside boundary but it doesn't impact us.
- No reason for my kids to switch schools without me moving.
   Sunnyside is much more conveniently located for a commute and is in closer proximity to Taylorview so that I can drop off all my kids in one route decreasing my chance of an accident.
- Not enough relief for Sunnyside
- Not over utilizing both schools is key. Good to see the problem not being compounded. With Longfellow elementary geographically nearby both schools can they not take more to relieve sunnyside?
   Unsure on utilization rate of Longfellow to know whether even an option.

- Right now it takes me about 5 minutes to get to Sunnyside school.
   If my daughter gets transferred to the new location, she would
   need to take the bus. As I have another child to get to ready for a different campus. I live on Spirit Cove.
- Scenario 1 looks like the best option for utilizing both Sunnyside and Edgemont schools
- Seems better to not leave a school at greater than capacity if you're going to address something. Sunnyside is going to continue to grow. It seems pointless to ignore this.
- Seems like a good possibility to support the growth that will come
   with the new apartments along the canal and Sunnyside as well as the Home Depot development


- Seems unfair to move kids going into 6th grade. Maybe any boundary changes could be optional for those students? It is a cool thing for these students to be "big man in campus" and those being moved would lose out on this.
- Some families will now be traveling farther to get to school causing more congestion at our intersections along the way.
- Still under utilizing Edgemont
- Students further away or new housing within Sunnyside boundaries should be moved to Edgemont.
- Sunnyside Elementary is still very overcrowded.
- Sunnyside Elementary School is still being overutilized.
- Sunnyside is closer to our current address than Edgemont, picked our neighborhood based on the schools our children would attend
- Sunnyside is overcrowded still but the boundaries seem to make more sense.
- Sunnyside is right near our home and neighborhood. Makes no sense to move them to Edgemont
- Sunnyside remains overcrowded
- Sunnyside still overcrowded in this scenario.
- Sunnyside still to high
- Sunnyside would still be overcrowded. The new subdivision by Taylorview will have a ton of young kids, so more students need to be moved.
- Taking families that live closer to Sunnyside(Belmont) and moving them out but leaving families in that live further away(Dunes and east of the golf course) and about equal distance to Edgemont does not seem logical.
- The area by Home Depot will add many students. The area behind Taco Bell has already had an impact.
- The boundaries do not make sense. I want to point out that Temple

View is at 85% utilization, and AH Bush is at 62%. Why are we only looking at changing the boundaries between Edgemont and Sunnyside if we have a greater need to shift more children to adjust for future capacity? Also, the district just added a new wing to Sunnyside elementary that was supposed to increase capacity? [REDACTED]

- The number of students attending lessens but still the school supersedes capacity.
- The subdivision we live in will be alienated. My children's friends at school will not live near us and his current friends will stay at Sunnyside. Also we are working parents, late start is an hour later at Edgemont than Sunnyside. It's hard enough getting my children to school at 9 when we are expected to be to work before 8. With school starting at 10 we will have to find childcare in the morning.
- There are the fewest amount of cons for this proposal, assuming any of the proposals will require a future solution beyond existing
   capacities. Which assuredly must happen given current growth
- There will still not be room. Edgemont and Sunnyside will both end up being at over 100% capacity. I think we may have to change bus times and spread the changes out to more schools
- This affects my children. It doesn't make sense to make us who live closer to Sunnyside go elsewhere but continue to let those who live farther away still attend.
- This allows for future growth at Edgemont
- This change will be very hard on my kids and the school is further away then what we're useD to.
- This does not solve Sunnyside's over utilization.
- This is a good step but still leaves Sunnyside over utilized.
- This is very unfair to existing students disrupting their current peer group. Creating stress on kids that are happy going to sunnyside.
- This one looks the best and least disruptive

- This plan moves the most children while not over utilizing Edgemont which will have growth with the new developments by home depot.
- This plan relieves some off Sunnyside but does not overcrowd Edgemont.
- This scenario does not do enough to fix the overcrowding at Sunnyside Elementary.
- This scenario does the best to alleviate overcrowding at Sunnyside while still leaving Edgemont at just below capacity. It also seems to be the best scenario that will allow for future growth - the last thing we want is for these poor kids to have to switch schools every other year. They need consistency and stability.
- This scenario doesn't plan for any growth for both elementaries. I do think having portables at Sunnyside is a good idea.
- This scenario makes the most sense to me
- This scenario only makes sense when you look at the income levels of the neighborhoods involved. This is a blatant attempt to move a lower income neighborhood out of sunnyside.
- This scenario seems to have the least amount of challenges
- This scenario still leaves Sunnyside well beyond 100% utilization. However, I think it makes the most sense and would sting the least.
- This seems like a bandaid for our current growth situation we are experiencing on the south side of Idaho Falls. The growth is not going to stop. It will continue. This will not solve the overcrowding problem of Sunnyside. The numbers are still too high. A new elementary on the south side of town seems like it's the only real way to solve the growth and overcrowding problem.
- This would boundary change would alienate my children by putting our subdivision on an island where kids in surrounding neighborhoods both east and west would go to a different school. They have friends in Avalon, Sunterra, and Sand Creek areas.

- This would make it so our neighborhood would be going to a different school then all the neighborhoods that are close by. Our kids would lose a lot of their friends that they now go to school with.
- Until a new school can be built to accommodate properly students in new housing developments should be bussed to schools with under utilisation.
- We are closer to Sunnyside
- We live in Belmont and I don't want to lose sunnyside! My kids will be so sad!
- We live in Belmont estates, as a household with two working parents the distance to edgemont and the later start time would impact our family and schedules drastically
- We live within a five minute walking distance, so as long as my son can continue to walk to sunnyside, then I feel pretty neutral. I'm not sure the change will affect us much.
- We need a new elementary school in this area OR we need to cap the growth and prevent more homes from being put in. The kids and teachers are too crowded at Sunnyside.

It is twice as far from Belmont Estates to Edgemont and will require parents to cross numerous busy intersections to pick up and drop off their children. - I am supportive of scenario 1b based on the statistical breakdown, allowing the schools to be more evenly distributed as far as utilization. If the board is only looking at the proposed scenarios, then scenario 1b would have my full support in comparison to the other scenarios presented, however, I think there are better options for boundary changes, but it would involve more school boundaries than just Sunnyside Elementary and Edgemont Gardens Elementary. I believe Edgemont Gardens Elementary should include the neighborhoods Shamrock Park and Cedar Ridge. This would affect the boundaries of Longfellow Elementry school as well, however, it would create a more clear boundary for Edgemont Gardens, Elementary school, as well as eliminating the "islands" currently occurring in their boundaries. Both Shamrock Park neighborhood and Cedar Ridge neighborhood are within walking distance of Edgemont Gardens Elementry. This would eliminate busing from these neighborhoods to Longfellow Elementry. This would also allow for Longfellow elementary to now take the Sunnyside acres neighborhood away from Edgemont Gardens, this is more

conducive seeing as how the Sunnyside acres neighborhood is currently surrounded by Longfellow boundaries. Scenario 1b does not allow for the inclusion of Shamrock Park neighborhood and Cedar Ridge neighborhood into Edgemont Gardens Elementry.

- I appreciate that you have left areas that are to the south of 65th to
   Sunnyside because it would be very difficult for us to go further.
- I do not want my children to be moved from Sunnyside. We live in the Sunterra/Yorkside Subdivision
- I don't love that this makes two schools overcrowded but it makes sense to decrease the stress at Sunnyside.
- I don't like the overutilization of two schools
- I don't love that it already overutilizes Edgemont. So it doesn't really plan for growth at both schools. But it does seem to lesson the burden on Sunnyside.
- I just hope the future of the area is really taken into consideration with these scenarios. Obviously both schools have tons more growth coming in the next year. I don't think we should move the Dunes neighborhood to edgemont because once all the growth and apartments are built and full then what? Move The Dunes out of edgemont and into another school? The new school? I just don't want my kids to be moved around from school to school. What NEEDS to be done is to change on a state level how schools are funded. The bond obviously isn't working and we NEED more/new schools. What is it going to take for Idaho to actually provide better education for our children!
- I like how this option better utilizes both schools and accounts for future growth.
- I like this option because it most equally shares the strain of overcrowding. However, it may result in two schools becoming very
   overcrowded soon.
- I think this would ease the burden on Sunnyside the most.
- I understand that multi unit housing is going in within Edgemont

boundaries but Sunnyside enrollment is still higher and will still continue to increase also. Edgemont could take more students before it reaches the amount of over enrollment that Sunnyside has seen for years and continues to see.

- If it makes it so Edgemont is going to be overpopulated when we know there is growth happening right now we shouldn't do it. Make a change that can last.
- In all the scenarios, we never had the option of staying at Sunnyside. Even though we are a lot closer in proximity than most of the people getting to stay at Sunnyside.
- In general I'd like to see another elementary school built to accommodate all the new growth. Builders should need to pay into a fund for schools.
- Is it possible to switch the dunes and lazy 8 to D93?
- It alleviates the overcrowding at Sunnyside at the expense of edgemont. There are several apartment buildings under construction in edgemont area that will put it in the same predicament that a Sunnyside is currently facing
- It appears to over use Edgemont which already has less resources than some other schools such as Longfellow and does not address the concerns with over use of Sunnyside
- It doesn't make any sense to move families that are closer to Sunnyside, but have families to the west of Belmont (that are farther away from Sunnyside) keep going to Sunnyside.
- It doesn't make sense to over utilize both schools and not allow for more growth in both schools
- It doesn't affect me, but helps the overcrowding at Sunnyside.
- It puts both schools over capacity and now we fear this is no room for any new students at both.
- It seems to me like a scenario that would overcrowd two schools and not leave room for growth is a lose/lose scenario. Not to mention the district wide scheduling changes that would come

along with that.

The roads are extremely narrow in the Edgemont area which increase accident again especially during the winter. They would not be able to attend after school activities as the school is to far away.
- My family lives in the Dunes. We spent a long time before moving to this neighborhood looking for a home because we didn't want to leave the boundaries for Sunnyside. My children have gone to Sunnyside for their entire elementary school education and our

youngest has only one year left before middle school. I do not want him to be moved to another school for his last year in elementary school.

- Same as last scenario

- Seems to address the over-crowding at Sunnyside the best of the 3 options, but probably doesn't go far enough. The Edgemont boundary should be moved further east and south.
- Seems unfair to move kids going into 6th grade. Maybe any boundary changes could be optional for those students? It is a cool thing for these students to be "big man in campus" and those being moved would lose out on this.
- Solution 1b is a temporary half-correction. Can they send more teachers and school portables to sunnyside to make it a better temporary correction until a new school can be built?
- Still doesn't feel like a solution, with two schools now being over utilized
- Sunnyside has a supportive and involved parent set that further allows additional help and resources to deal with the overutilization of the school. With this change now 2 schools would be overutilization and not allow for certain expansion within the boundary.
- Sunnyside is still over crowded. But all other schools should share in the overcrowding to the maximum extent possible
- Sunnyside still beyond capacity,
- Sure, Edgemont is overutilized in this scenario by a couple percentage points but Sunnyside sees significant reduction in pressure while still remaining ~20% over utilized. The othe schools need to pick up some slack. They can't, in good faith, continue to operate below capacity or right at (+ or -) capacity while Sunnyside is literally being overwhelmed.

- This scenario is the most fair of the three because it addresses the massive overcrowding at Sunnyside more than the other two scenarios. Please consider that the numbers we are reviewing do not take into consideration all of the new development in the Sunnyside area. This scenario will help this problem the most, but

#### it will not fix it.

It's time another school take on some of the growth this district is • experiencing as well.

- This would require a change of schools for The Dunes Subdivision •


(which is fine) but it would be nice to make sure this neighborhood will not have to be moved again the following year.

- We are closer to Sunnyside
- We built our home in the Dunes largely based on where our kids would attend elementary school. We considered elementary schools based on their overall performance in tests scores. That is why we chose to live within the boundaries of Sunnyside Elementary. The difference in test scores between Sunnyside and Edgemont is night and day. Aside from test scores, my children have friends and cousins that they want to continue going to school with at Sunnyside. We have loved the school and the faculty. I think it completely ridiculous to make people leave a school that they purposely purchased a home within its boundaries based on overcrowding. Especially when there is such a vast difference in test scores between the schools.
- We just need a new elementary school south of town! With this scenario both schools are still over crowded.
- What will happen when the housing development next to Home Depot on Holmes is complete? Apartments and townhouses, correct? Where will those students go?
- Why is there a tiny block right next to Sunnyside that would be sent to Edgemont? Seems like poor planning.
- Why would you shift boundaries to overload 2 schools when others in the district are so far below capacity?
- With the growth that will be taking place in the surrounding neighborhoods already in the Edgemont boundaries, I don't think it wise to over-utilize Edgemont.

- According to multiple resources, testing scores and student progress are considerably lower at Edgemont than those of Sunnyside making Edgemont considerably less desirable for my children's future. My children are established at Sunnyside and have a great network of friends and families that my husband and I have worked very hard to achieve and maintain by choosing our home location. As I'm sure most are aware, some of these areas are considerably more expensive to live in and it wasn't privilege that afforded us these opportunities. It was hard work to provide the best opportunities for our children. I do not support these changes.
- All in all we need brand new schools.
- All of these areas are far closer to Longfellow elementary. Why wasn't that school considered?
- Are there reboundary considerations for other schools as well? It is
   trsnge to me that Shamrock park ares goes to Longfellow instead
   of Edgemont when Edgemont seems closer and Longellow pulls all
   the way to the Yellowstone Highway.
- Belmont estates should remain within the boundary of Sunnyside Elementary. It is twice as far from Belmont Estates to Edgemont and would require parents to cross numerous busy intersections to pick up and drop off their children. - Edgemonts start time at 9:00am is a HUGE problems for working parents and grandparents trying to manage getting younger children to school and working full time to support families. Especially for single parents. Also Please consider removing children first that are on waviers that should not be attending schools outside their boundaries. That in my opinion those decisions should be on a VERY limited basis. Also the impact on children leaving their friends. What is going to happen if funds for building schools become available in the future from whatever source and then we have made these changes? Then What? Is this just a temporary solution?? Then we would have make changes again? Thank you for listening and considering my concerns.

- Elementary students who have been in a given elementary school for 3 or more years should be granted a waiver to finish their schooling at the elementary school--although they would have to provide their own transportation.
- Good luck! What a challenging matter to tackle!
- Has there been thoughts or discussions on other school boundaries, specifically any boundaries that are more fully developed and potential growth is much lower. These could be potential schools that could be utilized for growth coming in.
- Have we looked at all the kids on waivers? It does not seem appropriate to uproot kids if there is a lot of kids on waivers not at their appropriate schools. Plan 1a seems like the best option. Plan 1b moves the most kids and does not accommodate for future growth. Plan 2 doesn't even seem worth the time to consider because it is only moving 50 kids. Please consider what this is doing to our children.
- Have we looked at portables at the existing schools? Have we considered the fact that Sunnyside elementary is going to keep growing and growing? And encompasses all the new builds on the south part of town. Have we considered changing Longfellow and Sunnyside boundaries?
- Honestly, utilization and future utilization are the TOP priorities
   here. Walking distance is also top. Students already bus from the dunes allIIII the way to sunny side. Might as well send them to any other school for level utilization.
- I addressed this in the first box.
- I am not happy about a boundary change, but I can see that it is necessary because the bonds keep failing. I think we might as well make a change that moves a big chunk of students.
- I am open to whatever the district feels is best for the students. My daughter will need transportation if she won't be attending Sunnyside.

- I do feel there will be greatest push back from parents if current students are not allowed to remain at their current school. Meaning new students in the proposed boundary change are required to move but not currently enrolled students.
- I do not believe we pass the utilization problem onto another school and ask them do deal with the districts problems of not funding a new elementary school. I believe the support and involvement of the Sunnyside parents have allowed the overutilization of the school to be acceptable in the short term, although construction of a new school is vital for our community moving forward.

With other schools like Bush elementary being below capacity, why are we not looking more comprehensively at boundaries across the district, instead of forcing boundary changes only between the two areas currently served by these two schools. While we are at it, could we also look at making Compass Academy into a regular 3rd high school and redrawing boundaries so IF doesn't have an overcrowding problem? With the challenges facing our district I don't understand why we continue to limit our options because we might have to change boundaries, bus routes, or bell schedules.
- I feel that keeping neighborhoods closest in proximity to Sunnyside (namely Belmont Estates) in the Sunnyside ES boundary is the most desirable option. Thank you to all who are involved in this project. I realize what a massive undertaking it is!!
- I just hope we are taking into account all boundaries for d91 schools so that we are shifting schools appropriately and as close to the kids schools as possible. I don't mind if my child has to switch schools but I don't want to have to switch them many times throughout their time in elementary school.
- I know it can't always be fair, but where I live I didn't even get an option to stay inside sunnyside at all and all of the other neighborhoods got at least one option to stay which is very

frustrating to me. I wish there could be an option for my kids to stay like everyone else got one. I don't see why we aren't letting kids that truly live closer stay at sunnyside. I don't know why we worry about busing so much when parents are capable of driving their kids to school and we should take busing out of the equation. In Idaho and this area busing is a big deal which I have lived in other states and people have to drive their kids to school so I think it's unfair just because it works for buses that areas are automatically chosen to have to be moved and others just get to stay because of transportation, but it shouldn't be that way. People can drive their kids to school. And I think you should make the • boarders make more sense and have everyone on the east side of woodruff (15th) go to Edgemont.

- I live in the Dunes subdivision. I am willing to change schools because I understand the need for it. I would just recommend trying to make the decision that will prevent a greater amount of children from having to switch schools multiple times during their elementary years. This is a difficult task and I appreciate the time and efforts invested by everyone who is working towards a solution. I would encourage the District to run the bond again for new schools...again a difficult task but one we can't give up on.
- I think I may have been confused with the maps and clicked the wrong option voicing my support. I think Edmonton boundaries should go straight down Holmes and across 65th, moving as many kids away from Sunnyside as possible. I think it would have been better to change ALL the elementary school boundaries rather than just these two schools. I've looked at boundary maps. Longfellow's boundaries don't make sense either. It seems like we've been avoiding big changes for so long that now we are in a big mess.
- I think other boundaries need to be considered if students have to be bused outside of the boundary to get below capacity then that is what should be done.
- I think scenario 1 is best as it disrupts less students and families in a negative way. (Wish a new school could be built that would be closer for student more south)

- I think that option two serves the most students in our area at this time
- I think these are all well thought out plans. Thank you!
- I think we may have to alter bus times.
- I understand that the line has to be drawn somewhere and a time has to be chosen for the new boundaries to take effect, but I would like to see maybe a waiver into Sunnyside for families who have one kid left in elementary and only one more year.
- I wish there was a way to build a new school without needing a bond to pass in the elections!
- I would be curious about your plan for Edgemont to make the transition smooth with the additional influx of students. I'm assuming more teachers will be hired? More aides? Will we get an assistant principal? What steps will be taken to ensure that additional harassment/bullying won't occur? What changes can be made to improve the food program?
- I would like the boundary advisory committee to consider including the neighborhoods of Shamrock Park and Cedar Ridge in the proposal scenarios. This would affect the boundaries of Longfellow Elementary school, however, I think it would be the most productive to include these boundaries now than revisit the idea in the future. I also would like to know if any of the proposed boundary areas are also being considered for annexation in the recent proposal that was presented by District 93. I would hate to make a decision on boundaries only to have those boundary areas consolidated into a different district.
- I'd rather see Edgemont and Sunnyside equal utilizations or as close to as possible.
- I'm disappointed Sunnyside elementary continues to be very overcrowded. I'm also disappointed the bond failed to receive the necessary support to fully fix this problem. Continued growth on the south side of Idaho Falls will continue to make overcrowding problem worse. The realignment options do not fully alleviate the

overcrowding. This appears to be a temporary partial fix at best.

- If bus transportation time is really an issue for Edgemont, then scenario 1a looks like the best option.
- In general I'd like to see another elementary school built to accommodate all the new growth. Builders should need to pay into
   a fund for schools. This should be part of the planning and zoning process.
- It makes the most sense to do whatever plan is going to allow for 

   the boundaries to stay the longest
- It sounds like Sunnyside elementary is where the issues are at.
   Address those! Don't make problems at Edgemont. It is doing wonderfully! If you try to solve problems of Sunnyside by pushing to Edgemont, you will just have two elementary schools with problems, not just one...
- It would have been nice to just have a vote on only building a new elementary school instead of looping it in with the high school bond so that we didn't run into this problem.
- It's just seems like None of these solve the problem because you say Sunnyside will still be overcrowded or both will be. Can we look at changing boundaries for more schools and spread it out. Also my concern is also for kids you will be attending 6th grade next year- will an option be given for them to finish their last year at their current school? It should be given! Those kids having to move for that last year is devastating to lots of them
- It's obvious that more boundaries should be shifted. The existing boundaries are ridiculous. This is blatant gerrymandering. Make an attempt to load balance all schools and keep contiguous boundaries.
- It's important to make the boundaries ready to understand and to not overburden Edgemont.
- Keep everything the same
- Leave the current kids and their siblings (makes pickup and drop

offs less complicated) where they are. If you must implement this new change, apply it to new students

- Make sure this is a long term solution, not good for the kids to have to change too much
- Making a change that does not provide significant change is not worth making. If you are reassessing boundaries change what needs to changed to optimize utilization of both schools.

- Merge D91 & D93 and do a full system-wide boundary realignment to fully utilize all area schools. There is no reason to have 2 school districts in such a small community. Look at how large and efficient school districts can be in other states. Alpine School District in Utah for example has almost 85,000 students in about 90 schools all within 1 district. Not to say that Idaho needs a district this large but combining the 2 districts in Idaho Falls and sharing resources, revenue, debt, and such could be a huge benefit to all involved.
- More than ever children need stability. Maybe ask for volunteer transfers or build annexes. Boundary change is too disruptive for some.
- My concerns are moving my children around too much. We are all new to this area of town and my children are making friends at Sunnyside. I'm concerned with the constant switching around of schools as I am more interested in a new elementary school built as it feels more of a permanent choice. I understand we need to help ease Sunnyside and Edgemont looks like a nice school. Please keep in mind if our end goal is to still build a new elementary school can we place more focus on that than switching kids around for "temporary" reasons. I want my kids to feel comfortable at their school and not have to constantly deal with changes. It seems like this decision has already been made to move our neighborhood to Edgemont so if that's the case I just ask that most of the surrounding neighborhood go together so it can feel somewhat familiar to the children.

- Sunnyside is way over utilized. None of the proposed scenarios bring it close to 100%. I believe a new school is the only option.

- The impact is only a temporary fix. And my children would suffer emotionally for a temporary fix!!! They have excelled even with

crowding at the school.

- The overcrowding at Sunnyside and the under utilizing of Edgemont is not advantageous to the student's, staff or educators.
- The real answer is building more schools. If developers are building homes at this crazy rate they should also be required to donate land for schools or build a school for their developments
- The reality that sunnyside is overcrowded, necessitates the fact that neighborhoods who utilize bus services to get children to Sunnyside should be looked at first to be sent to different school other than Sunnyside. If there is enough of a population density within walking distance to fill Sunnyside to 100%, that should take priority. Sunnyside street, Holmes Street, Rolendet street, and 49th should be the FIRST boundary (excluding the new Rockwell subdivision shoved in this boundary). If this specified boundary fills Sunnyside to 100%, then those outside of that boundary should go to a different school. Thanks for all your help on a difficult scenario that our planning and zoning committee and large builders (Rockwell) failed the community on and left the school board to figure out. No matter what scenario is chosen, there will be people who will be upset. It's best to do it right the first time, and correctly as to not have to revisit this in a year.
- The staff and teachers at Edgemont elementary are amazing and wonderful. They supportive and kind. The boundary proposals are too narrow minded and should be looked at on a district wide level. We need to find a way to even out the elementary population between all elementary schools in the district. I want to point out that Temple View is at 85% utilization, and AH Bush is at 62%. Why are we only looking at changing the boundaries between Edgemont and Sunnyside if we have a greater need to shift more children to adjust for future capacity? Also, the district just added a new wing to Sunnyside elementary that was supposed to increase capacity? And as long as Kylie Dixon is principal at Sunnyside, the district will need to find an elementary for my children to attend elsewhere. And we would prefer to go to Edgemont.

- There is a small neighborhood at 11th east just south of 49th this is in the same church ward as the Belmont estates and the subdivision just west of Holmes. I would prefer it most if all these neighborhoods/subdivisions were in the same elementary school bojndaries
- There is really no great way to boundary change. A new school is really the only option. I think these boundaries look like a good temporary fix.
- There is still a lot of building going on in the south of Idaho Falls. We need to keep that in mind as we make this division.
- This change won't effect my family thankfully. But I feel that students that have already been enrolled and attended sunnyside should be able to have the option to stay. Any new move ins can follow the new boundaries.
- This is all tough! I support you!!
- This is depressing.
- This should not even be an option. It does not solve overcrowding problem. It's a bandaid! The only way to solve this problem of growth on the south side of town is a new elementary school!
- Those in new housing developments should be assigned to schools with lower utilizations. This is not an uncommon practice. While living in WA for a while my student (and all students from our apartment complex) were bussed 5 miles to a school that had a lower utilization. The apartment complex was built and the school closest was not able to accommodate.
- We built our home 3 years ago specifically choosing our lot in Belmont for our kids to attend Sunnyside. Our children's school was one of the highest determining factors in building where we did. It does not seem like these schools are equal in the education kids recieve. I'm sorry, but when you look up information available online and compare the 2 schools they don't match up. Sunnyside has more kids that test above grade level compared to Edgemont which seems to be below grade level. It is important to me that my

kids do well in elementary school and find a love for learning and going to school. I also feel like projected class sizes would have been helpful in the data provided. I know my kids are in classes with around 24-26ish kids each year, but I have also been in those classes and helped out and the students are very well behaved and seem to be excelling in all subjects. I can speak for myself, but also probably many other parents who would be happy to go in and help in classrooms and help teachers to lighten their load at Sunnyside. We love Sunnyside and want to keep our kids there where they are established with teachers, staff, and friends. Scenerio 2 is the one that keeps the kids closest to Sunnyside there.

- We built our home in the Dunes largely based on where our kids would attend elementary school. We considered elementary schools based on their overall performance in tests scores. That is why we chose to live within the boundaries of Sunnyside Elementary. The difference in test scores between Sunnyside and Edgemont is night and day. Aside from test scores, my children have friends and cousins that they want to continue going to school with at Sunnyside. We have loved the school and the faculty. I think it completely ridiculous to make people leave a school that they purposely purchased a home within its boundaries based on overcrowding. Especially when there is such a vast difference in test scores between the schools.
- We have to consider the future growth within Edgemont that we are already aware of. Also Edgemont is a difficult school to attend because they do not start until 9am which can be difficult for parents who are use to an 820 start time.
- We love edgemont and the one on one attention that our children are getting with the smaller class sizes.
- We need more funding for public schools.
- We need to also look at Theresa Bunker elementary. It is so old!! Not enough room for growth. It could use a remodel like Sunnyside had.
- We need to change the super majority law for votes on new

schools and only vote on one school at a time, so as to not overwhelm the community.

- We need to make the schools as even as we can so we don't hurt our students education with overcrowded classrooms.
- We need to revote on the school bond. We need that to pass and get rid of the out dated 2/3rds super majority. This is not the answer. Just a bandaid solution. Let's get the bond passed and start building schools!
- We seriously need to do whatever possible to build a new south elementary. If we must change boundaries, scenario 1A makes the most sense looking forward, as it affects the smallest amount of students/families. It would also be the best way to transition if/ when we are able to build a new south elementary.
- What about students with IEP's? This is our first school year in Idaho Falls and our son is doing phenomenally well with his current IEP team & teachers at Sunnyside. I do not wish to go through the whole process of meeting a new IEP team when he only has one more year of Elementary left. Would he be allowed to stay at Sunnyside. It would be in his very best interest to be allowed to stay. We have been through numerous IEP changes over the years and every time we have to change it takes significant time for him to settle back in.
- What happens to sixth graders in the event they are zoned to a new school? In the past, they've allowed sixth graders to finish their elementary school career at their current schools. Would this be considered?
- What will happen when the housing project next to Home Depot is complete???
- When we think about moving children from one school to another ais future growth being considered? Such as the developments that are being built where the Monrach or by Home Depot that are going to put pressure on these same schools. How is that going to be handled? In one of these scenarios the proposal is to move

only 50 kids seems not hardly worth it for 50 kids. Edgemont is less crowded and has lower test scores with less kids. I am concerned about that. If they are not overcrowded but test scores are lower what will happen when they get more kids? If there is possible funding in the near future then why not just leave as is for the short term? Thanks for taking the time to consider my thoughts.

- Why are only 2 school boundaries being redrawn? There are other schools in the area that probably need to be considered as well.
- Why not push Edgemont boundary further south?
- Will all these kids have to be up rooted again when a new school is eventually built? None of the scenarios make sunnyside under 120% capacity. So even uproot all these kids at all?
- With the future growth at Edgemont that will come from the planned development near Home Depot I would want to over fill Edgemont too early. There needs to be some help to sunnyside but I would not want to see both schools overrun. It would out a lot more pressure on the teachers and staff at the schools
- With today's technology it is easier to find and understand district boundaries. Try not to plan boundaries with ease of understanding in mind. Do what is best to utilize both Elementary schools evenly.
- You guys don't take into consideration the children with specific health needs. For example our son has Type 1 diabetes and it's taken us almost 2 years to get to a place where we feel comfortable with him at school. Because there isn't a nurse at the school all the time, which is crazy. It's just frustrating for us because it took us this long to come up with a plan where the school and our Dr are working together. I get that you can't make everyone happy and are trying to do what's best for the most people, but kids with specific health needs have a harder time adjusting to new situations. I think this should also be a consideration when moving kids out of their normal environment.
