Rosa Parks is a high-needs school due to the population. Staff turnover rate was high which affected the school performance. It has been getting better, and students' performance is getting better, especially this school year. If Rosa is going to host more than 700 students, has the district considered how many teachers and supporting staff will want to work at an overcrowded and high-need school? In this option they will still only sitting at 55% utilization in 5 years, that's a 2% drop. Plus with those 270 empty seats with no prediction of growth why move them? If they became a neighborhood school the weight of mutilation of

- Creekview and Mayfield would be lessened from now until the projected 5 years.
- I'm ok with option 1. My main concern is for my son to still be able to attend Central Academy for 6th grade. I already have one 6th grader, he will be at the Middle School next year so I'm not worried about him. But my 5th grader really wants to be able to graduate 6th grade from Central Academy. Both of my children have attended Central Academy since Kindergarten.

properly staffed? -We have never had a student population at Rosa Parks of more than 600. A large number of our students struggle academically. How does it make sense to put over 700 students in the building with no regard for enough restrooms, cafeteria space, specials, recess, etc. and expect them to succeed? -How will we support lunches/recess, unified arts, bathrooms, etc at Rosa parks with 700+ students? - Way too many students at Rosa not enough space for cafeteria usage, bathroom facilities, specials, special education classrooms, no fence around playground for almost 800 students -OPTION 1: While Rosa Parks Elementary has space according to the blueprint for classrooms, saying the building can hold 716 students does not take into account the capacity for art, music, and PE programming, the potential increase for special education space, cafeteria space, playground and bathroom usage. The building only has 4 toilets in boys' restrooms on the classroom side of the building. Having that many students in a high need building increases behaviors resulting in discipline referrals and lost academic progress. - Option one would put my three children at Rosa Parks I would prefer to keep my children at Amanda Elementary because I have a child who is autistic and has an IEP I am concerned that him changing schools will negatively impact his learning. I'm also concerned about the support he would receive at Rosa Parks and if it would be the same amount of support he receives at Amanda. My son had a difficult time adjusting to school since starting now that he is in 1st grade he has adjusted well I am concerned he will not adjust well and it will set him back if he is forced to change schools and be with people whom he is not familiar with.
- Our address is smack dab in the middle of the city and this option sends us to the farthest elementary school on the edge of the city (miller ridge). This option bypasses atleast 3 closer elementary schools including the closest Mayfield (our current school) is 1 mile from our home.
- Our closes school is mayfield, option 1 seems to be the best option for us not being more than 5 minutes from school.
- Our current elementary districts have 74% of the students at their 1st school. The number 1 community request was to have students at their closest school this plan is less than that. Additionally, the second most important criterion for the community from your first survey was the fewest number of students moved. This option does not have the fewest number of students moved. Another thing that the community was concerned with was an equitable number of students across schools and the numbers are very equitable.

 Putting 716 students at Rosa Parks will be chaotic. We've never had more that 600 students in any given year. The "program capacity" number for our building is unrealistic, considering only classroom space and not lunches, restrooms, specials, and all that comes into play in an elementary building. In addition, since a new grade level will be added, how will there be space for band and orchestra?
 Choir? These are daily classes, not on a rotation like current specials at our elementary buildings.
- The option is ok
- The options presented are all very similar from one to four. I would like to see more options presented including re-establishing Highview Elementary as a neighborhood school. Based on the information presented, there are a significant number of students living in the area that are attending schools further from their actual neighborhood. If Highview were a neighborhood school it would

- allow those students to walk and have the benefit of creating a school community of their neighbors. Of the options presented, I believe option four is the best since it disrupts the fewest students.
- Think about all students and class sizes. A plan that helps with reduction in class sizes would give students a better teacher to student ratio making for a better learning environment with a possible increase in test scores!

- This plan was originally my second favorite of the options but i think more even distribution of some of the students would benefit this plan more. This will most likely change the "Assigned to Closest School" increasing the 2nd and 3rd closest options. And will move approximately 50 more students; bringing the new total to approximately 346 students moved. Decreasing the number of students moving from Amanda to Rosa Parks by approximately 36. To have approximately 149 moved from Amanda to Rosa Parks instead of the plans original 185 would help Rosa Parks stay around 75% Live-In Utilization. On the same note I think moving approximately 49 students from Mayfield to Amanda and approximately 37 students from Creekview to Highview would be beneficial to these schools. It would allow Mayfield and Creekview to sit around 75% Live-In Utilization while bringing Amanda closer to 59% and Highview closer to 63% Live-In Utilization. This would help Mayfield and Creekview to potentially have smaller class sizes than the original plan was allowing while taking advantage of the extra empty space at Amanda and Highview while not making their class sizes much larger either. Smaller class sizes are beneficial to both students and teachers. Students learn better and get more one on one time with the teacher in smaller classes and smaller classes are less taxing both physically and mentally for the teachers. Originally this plan seemed fairly balanced compared to the other options but when stepping back and looking at it as though it were the only plan I saw that it would benefit from a lot of changes. To ensure the

teachers at Mayfield and Creekview wouldn't become over taxed with a high volume of students compared to other schools in district, a lot of students needed to be moved including approximately an additional 50 students. Because of those reasons this option fell from my second favorite option to my third favorite option even with all the changes I proposed.

We have no sidewalks, street lights and semis going up and down Oxford State Road, and FOUR train tracks that our students will have to cross. None of these are a reliable form of transportation to school. We should also be taking

- Don't like this option
- Equitable distribution of assets will be a major factor for Rosa Parks employees with this option. Taking all elementary buildings to a portion of capacity, yet pushing the capacity of the building in the

highest needs census tract of the MCSD community feels out of alignment (Rosa Parks). Again, thoughtful consideration of personnel, funding, and specific academic and social-emotional needs of the Rosa Parks community is of highest concern. Equitable distribution of assets and personnel to support the higher demand that will be placed on that building, specifically.

- For Rosa Parks what would be the socioeconomic status vs the other schools. With the projected neighborhood includes many areas of low income housing which in return often creates more needs of intervention. Would this be taken into consideration with staffing needs for academic and behavior support. Rosa Parks would again have almost 250 more students than other elementary schools how would lunch, recess, specials be affected?

I think keeping the 33 students meant to move to Creekview from Miller Ridge at Miller Ridge would lower Creekview's Live-In Utilization to approximately 77% while bringing Miller Ridge's Live-In Utilization up to 58% which is lower than the plans original 74% because of the 121 students redirected from being moved to Miller Ridge to Highview. To keep the teachers at Rosa Parks from being over taxed I think keeping approximately 73 students at Amanda and lowering the number moved to Rosa Parks from Amanda to approximately 112 instead of the original 185 would make more use of Amanda and reduce the strain on the teachers at Rosa Parks. These changes would reduce the numbers of students moved by approximately 106 bringing the total approximate students moved to 416. It should also improve the students going to schools closer to them. Because the improvements to this plan are fairly simple compared to the others this plan went from my third favorite to my second favorite option.

Bathroom break schedules? Given the lunchroom capacity what strategies are proposed to manage lunch periods effectively for 720+ students? What are the anticipated changes to drop-off and pick-up processes, and how will the plan address potential bottlenecks or delays? How will the redistricting address the rising number of social-emotional emergencies (e.g., selfharm, suicidal ideation), particularly with all our elementary schools having only one counselor? Other considerations; How does the redistricting plan account for demographic data (e.g., from recent census tracks) to ensure equitable representation and resource allocation across the community? What metrics or benchmarks will be used to evaluate the long-term success of the redistricting in improving academic outcomes, operational efficiency, and equity? What is the plan to ensure adequate staffing levels for bilingual teachers, SPED staff, and IEP/504 accommodations, considering the current percentage of students requiring these services? How will the proposed plan aim to minimize the number of families impacted by redistricting while maintaining equity and efficiency? Are you aware of the benefits of maintaining continuity in learning environments for students, including the role it plays in fostering stronger teacher-student relationships and enhancing academic outcomes? numbers of students that are within a given attendance area that attend other schools, is that because of open enrollment or because of district placement? -Woolpert's representative did not have much personal information about the area, locations for the school, and the school's surroundings. For example, that Amanda does not have sidewalks, lights, or ravines that flood with water. There is no walkability with those conditions, the trains, or the semis traveling up and down Oxford State Road. On the last census, 2 or 3 areas of the census revealed that the students in the Amanda community were the POOREST in southwestern Ohio. -Has conversations occurred around student data and the needs of students? Academic? Behavioral? Social Emotional? -There were other options, but only these 4 rose to the top, why were we not shown all of the options? -Not any one of these options as is, but will end up being a combination based on the survey results. That is NOT what was originally presented. - "Amanda is just out there"-Karen Jackson. Miller Ridge and Amanda are about the same distance from the heat maps center of student populations. Miller Ridge and Amanda are 3.9 miles from the center of the district. Miller Ridge has no orange. Amanda has more orange than Wildwood. Creekview barely has orange. -While answering a parent's question about Central at Highview - a parent asked about what would happen to the Butler County ELC. He was concerned that it would be another place for Middletown that the homeless would take over. Another parent listening brought up selling it and someone said that a charter school could come in and purchase it and that would take money away from the district. The Woolpert representative stated that does happen to empty school buildings. -As educators, the safety, well-being, and academic progress of all students and families we serve should be the focus of our decisions. I hope these have been considered for ALL of our students and families, even if we have not heard their voices in a survey. -As a whole, no one was unaware that the options presented tonight were not one of the final options that would be presented to the board. Will we have a chance to give feedback on the final option prior to it going to the board? -Change is never easy and while I understand the need for us to

be fiscally responsible we should be most concerned about our students and their well-being and progress. Placing high numbers of students at Rosa Parks puts a strain on our building in many ways. Our students function better with smaller classroom sizes. The discipline referrals are down this year, and that is due to our shift to trauma-informed practices, our cultural shift, and smaller class sizes. Our students are reaching higher levels of achievement due to smaller classes and appropriate staffing. We have been able to focus on individual needs and meet those needs in a more effective way with a smaller number of students in each class. -Why is the admin team the only members of the redistricting committee? --MTA & MCEA presidents --should have teachers, maybe one from each school impacted by the results of the redistricting --should have community members -SLEs are considered homerooms, but at the 112/11/24 presentation, "intervention spaces were not considered as homerooms" -Will SROs have more time in each building? -I do wonder if the consultants visited the buildings to see the functionality of the spaces with students actively learning. Simply adding up classrooms and multiplying by a contracted number of students does not give an equitable, safe, and functioning feel for a building's capacity. -My other question is why when we are under the same contract do the staff and programming at Central Academy get the protection they appear to have? Their numbers have not been changed in any of the models. Why can't they have more openings for students? What will happen to the extra space Highview will have when they move there? -Has the percentage of students in each area with identified disabilities been taken into consideration? -I feel like there needs to be an additional option that increases the student number more at Rosa from Option 4, but less drastically than what is seen in Options 1-3. Redistricting elementary schools can negatively impact Black students by potentially increasing racial segregation, disrupting established community ties, and potentially placing them in schools with lower resources or academic standards, ultimately hindering their educational opportunities and exacerbating existing inequalities. -If Rosa plans to host over 700 students, this decision could place it in a challenging environment characterized by limited resources and underperformance. High student numbers often lead to increased workloads for staff, resulting in burnout and a high turnover rate. Additionally, schools serving large populations typically face socio economic challenges that further exacerbate these issues. By considering these factors, it's clear that hosting such a large student body may hinder Rosa's ability to provide a quality education and support for all students. -Why is central allowed to stay the same and determine who can and cannot be admitted to their school when all the other schools have to admit anyone who lives within the boundaries. There are so many concerns that come from central at the middle and high school when students in the district are not held to the same expectations (central not being like everyone else by having multigrade classrooms, non graded school, etc.). This school not having to change along with everyone else is not okay. If the district is changing, it needs to impact central and how they do things too. -How have the percentage of enrollment utilized numbers being calculated? Are they taking into account the MD or ED classrooms that must house fewer students or are they maxing out every single classroom with 25-28 students? Also, it would be nice if they would plan ahead. We have split rooms built in at each newer elementary building because those were specifically made to be reading diagnostician rooms (thing of the past) but the rooms remain and aren't as conducive for regular Ed rooms. In addition, we built on at Rosa Parks (despite people voicing concerns about the cost/logistics of bussing kids from all over town to RP). Turns out, that program didn't work and RP now has several classrooms and communal space that is rarely used. We need to look at areas that will be developed in the future (I'm sure the city will work with us on this) and do everything we can to ensure we will have space at a neighborhood school for any new developments. No one wants to do this again in 5-10 years. -What

happens when Amanda gets Leader in Me Lighthouse status and all that money is wasted if that school is eliminated? -If the numbers didn't play out last time (ex Miller Ridge expected to be in an area of a major boom in population), how can we be expected to believe the numbers this go round? -"Central academy is the crown jewel" - Karen to a Central parent that was concerned about --"Highview is not in a nice area" --"Some areas of Middletown are not as nice as others so what about our Walk a thon?" --"Will they just open the flood gates and let anyone in since the buildings will now need to be used at a higher level of capacity and Highview is so much larger?" -Will we still have SROs? -Amanda is one of the highest achieving schools in the district. They are a Leader in Me school close to lighthouse status. Why would you propose options that try to make that school irrelevant? That community will not want to send their kids to neighboring schools. Why on earth would central get to move into highview? Will they now be a neighborhood school, they are really no different than the other elementary schools in middletown, nor are they higher achieving than the rest of the schools. How about taking into consideration all of the middletown communities instead of the chosen few which by the way are not all out achieving the others. -Why were the original proposals thrown out and new ones created without conversations? -How will BAND and ORCHESTRA be affected at the 6th grade level? -The focus of this redistricting process is "optimal utilization" of school buildings. If this is the case, when Central Academy moves to the Highview building, it has more space to host more students (Live-in Utilization 57%). Why is the district not considering adding more students to Central Academy to release some of the pressure on other schools (Livein Utilization 76-83%)? -How much does it cost to bus students to Central Academy? The cost to drive students all over Middletown from Central new Highview seems like it could be a lot. Parents should drive their own students to Central if they choose this option. -How will the 6th grade be handled in the elementary? Will there be multiple rotations as it currently operates, or will it be similar to the current departmentalization in the elementaries? -Is there a map showing the industrial areas, like CLIFFS, as well as Miami, the parks, retail areas, etc. no students are going to be living at these places. This would give a better picture of our community and also show more potential boundaries when considering walkability. -Central Academy should be at Rosa Parks to fill that space, especially considering they are both schools of choice. (Please recall that was part of the selling of adding the expansion to Rosa Parks) If space is a question, Central is a school of choice as is with students having to be accepted, so only accept the students that will fit into the space available at Rosa Parks. Actually, looking at the current boundaries with projected Live-In Enrollment, Rosa Parks is projected to be at 496 and Central at 355, having those two schools come together, the enrollment would be 851. At 851, that would be at 95% usage. At 95% usage, this would meet the goal of having the best utilization of the buildings set by our Superintendent during the Redistricting Presentation. -Have you accounted for the extra student load on the building infrastructure (restroom, cafeteria, hallway space for students to pass safely through) and out structural concerns. -Extra a use of other equipment in the build, extra supplies needed to support the extra students. Moving students to a building is not building cost free. There are costs that will trickle down effect to each building. -Central will only occupy part of highview so what will the rest of the building be used for? -Have we considered neighborhoods that would be walking, but do not have street lights or sidewalks for students. -Why is central not turning into a neighborhood school? -ENROLLMENT (per WOOLPERT) 24-25 = 5912 enrolled 34-35 = 5557 enrolled K-12 total = 5627 enrolled PK-12 total At most, 355 students lost over 10 years. So, why the panic? -The central model isn't working so why not get rid of it and turn it into a neighborhood school? -Woolpert staff said up to 2 buildings could close down, so are there plans to close another school in the future? -Why are we given 4 options to vote on but then told that the final decision will be a combo of all options? -What does the admin say about the blatant gerrymandering occurring with the boundaries and how that is a violation of Brown V Board of Education by keeping boundaries unequal for the "haves and have nots"? -When evaluating options, cost

should be a significant factor, along with the effectiveness of schools and retaining strong, cohesive staff teams. Proximity for families, such as the ability to walk to school, is also crucial. -How reliable are the projections for future development areas? For example, Miller Ridge was built 20 years ago with expectations of substantial growth, but many families in the area did not choose Middletown City Schools. Currently, new developments are underway or planned near the old Lincoln Elementary, Roosevelt Elementary, the former hospital site, and the old Vail site. These areas are closer to Highview than Miller Ridge and would require fewer buses and routes if students attend Highview. Have the transportation costs for these scenarios been thoroughly considered? -Why is Central Academy still viewed as the crown jewel? It is in no way performing, presenting, nor producing in the manner that it did when all schools were site-based. Central Academy is no longer non-graded. They have the same curriculum as the rest of us. They struggle with behaviors like the rest of us. They are not number one in achievement or growth. -Highview should be a neighborhood school as that was the original plan for the school as sold to the taxpayers and staff. -Amanda should move to the Highview building considering a lot of their current students were displaced to Amanda from Highview when Highview became the 6th grade center. Allow the neighborhood to finally use the school that is actually down the street. -Put Central Academy (355) into Rosa Parks (496), the enrollment would be 851. That would be at 95% usage. If that number is too high, perhaps limit the enrollment at the "school of choice". -Shut down the current ELC building (saving \$600,00 annually, per Karen during question/answer), move it to Amanda. Then, move Amanda to the Highview building, move Central to Rosa. If the numbers call for it, there could be 2 ELCs, one at Amanda and the other at Central. (side note, If shutting down one building would save \$600,00 does that mean that shutting down the current Central building as well would also save \$600,000 as well?) -The Amanda neighborhood doesn't have sidewalks and has multiple trains that run through neighborhoods. How can the walkability improve? -If the community is asking for neighborhood

schools to attend that are the closest to their homes, how is it that Central is either of those things? -PERFORMANCE INDEX 3 YR GROWTH Amanda 10.5 Central -2.2 Creekview 5.8 Mayfield 3.6 Miller Ridge -1.2 Rosa Parks 4 Wildwood .1 Central Principal on TIKTOK -Central Academy is not the only building that supports project based learning as suggested It has not been board approved that Central Academy is indeed moving to Highview -Stating that Central Academy is staying small is infuriating for those people who will now be working at optimum capacity, the same capacity that Mayfield is currently operating at and the staff already feels like they are overcrowded. -Stating that NO Central Academy Staff will be affected is presumptuous, again no plan has been board approved -Everyone keeps saying "NO DECISIONS HAVE BEEN MADE" How can he be saying any of this? -It is upsetting that it is allowed to be publicized that Central is the only school that focuses on the social emotional learning of our students. Each teacher in our district knows that inorder to get to teach, we must first secure our students' social emotional standing if we ever expect to teach. -How can he say that the enrollment at Central Academy is secure? They are not a neighborhood school and the first survey indicated that was the community's desire. -If not becoming any larger, then the students in that neighborhood would not be able to attend the school closest to their home, nor could it be considered a neighborhood school. -My questions are for all the "options" or as we were told it will be a cumulative of all feedback to be the final choice. 1. Why is central moving into a bigger building that they will not fill? 2. Who will take over that empty space? 3. How do you plan on running an ELC with one hallway bathroom? 4. Is this ELC Butler County Head Start or Middletown City Schools free public preschool? 5. Performance Goals show that the model Central currently runs is not applicable, in this day and age. Why is there no consideration to make it a neighborhood school? 6. What will classroom sizes look like? 7. Teacher/Student ratio 8. How many homerooms are we moving to? 9. How can you guarantee jobs for all current staff when you know it's not applicable.

Are we paying for bussing for Central Academy? If so, should we look to

have parents provide transportation to the new Central/Highview? We must have many busses to Central currently and if parents want this option, they should have to get their student. How much does it cost to bus students to Central per student compared to our other elementary schools.

- Bavarian area need to be moved to Creekview schools it's the closest school to us!
- Being told by Woolpert staff that we are voting on 4 options but the final decision will be a culmination of all options seems counterproductive and frankly, stupid. What is the point of voting? Also, being told that Central Academy is the "crown jewel of Middletown" is a slap in the face and an insult to every other school, student and staff member in the district. In addition, Amanda Elementary being described as "really far out there" in terms of distance when its not, is insulting too. Please consider how you present the options in the future and watch how you say things because it might not seem insulting, but it is.
- Build a new school.
- Central Academy needs to be removed as an option. It is inundated with students and there have been an increasing amount of problems that the teachers simply cannot handle with class sizes of about 24 kids each. Move the teachers of Central Academy to the other schools there they need help to make the class sizes smaller. Mr. Sippel is an amazing principal. He could be a part of the district team that helps with all the schools.
- Change is never easy and while I understand the need for us to be fiscally responsible we should be most concerned about our students and their well-being and progress. Placing high numbers of students at Rosa Parks puts a strain on our building in many ways. Our students function better with smaller classroom sizes. The discipline referrals are down this year, and that is due to our shift to trauma-informed practices, our cultural shift, and smaller class sizes. Our students are reaching higher levels of achievement due to smaller classes and appropriate staffing. We have

been able to focus on individual needs and meet those needs in a more effective way with a smaller number of students in each class. I do wonder if the consultants visited the buildings to see the functionality of the spaces with students actively learning. Simply adding up classrooms and multiplying by a contracted number of students does not give an equitable, safe, and functioning feel for a building's capacity. My other question is why when we are under the same contract do the staff and programming at Central Academy get the protection they appear to have? Their numbers have not been changed in any of the models. Why can't they have more openings for students? What will happen to the extra space Highview will have when they move there? If Options 1, 2, or 3 are chosen, are there plans how Rosa Parks will service the students for lunch, recess, and Art, Music, PE, and Passport? While the plan says we have classroom space we do not have extra space for those things. Bussing is also an issue. We had many students the last couple of years who did not arrive at school on time. Some were missing 15-30 minutes of instruction a day. With that many students it will clearly add the need for longer bus trips and more buses. As educators, the safety, well-being, and academic progress of all students and families we serve should be the focus of our decisions. I hope these have been considered for ALL of our students and families, even if we have not heard their voices in a survey.

- Choose option 4!
- Communities need to stay together. Kids needs their support teams which is the teachers they are familiar with!
- Did you consider the racial disparity and special education services needed by these populations? Again, why does Central Academy get a huge building to sit at half capacity? Why bother to move them at all? The point of this was to use buildings to their utilization and this directly contests this notion. Very frustrating that you essentially gave three almost the same options and a fourth that is clearly the best, but listed with all the cons indicating this best option isn't one you're even considering. This was poorly presented in every aspect.

 their families.
- I believe that this whole process has not resulted in a outcome that will benefit our community in the long run.
- I choose option 3.
- I don't feel like I have options. All four options move me to the neighborhood school that I wanted to avoid. All of my three kids attended Central academy since 2013! I love that school and don't want to move my

son his last year to a new environment and different learning style . He thrives at Central and I don't want to disrupt That by moving schools! Central Academy was a separate school for a reason. Leave it that way. Give parents options to choose an alternative school. I don't care what schools the kids go to in my neighborhood. That isn't my concern.

- I know all Middletown Elementary Schools don't have the same scores. I
 feel like taking kids from schools with better scores and putting them in
 lower scoring schools is a bad idea. Plus taking kids from their school
 they've been going to for years seems like a bad idea too.
- I like option 1 the best. It impacts the fewest students possible and allows students to go to school closer to their homes.
- I like the option changes involved with making elementary schools K through 6th grade. I'm a school psychologist and feel we push kids to grow up too soon. The move of Central Academy to Highview makes sense to me and I appreciate the cost saving aspect as well. Moving children to a lower performing school in an unsafe neighborhood like Rosa Parks is a tough sell!!
- I really hope the redistricting dosent effect kids next year being away from friends ESPECIALLY kindergarteners my daughter just learned her school and it is the closes one to our house. I may have to think of other options if we are redistricted other than Middletown even if we have to move or home school.
- I struggle to understand how this is an appropriate move for our students that are currently at Central. Moving to Highview means that we are becoming a neighborhood school, which I do understand that more of Middletown should have access to the incredible staff and family atmosphere that Central currently provides. I also understand that the program is significantly different from when my sisters and I attended. But to tell the public that Central will remain as it is now, is either a disservice to the program or to the community. To Central because we will become too large to be "Central Academy" or to the community, because there is

no intention of Central at Highview becoming a true neighborhood school.

- I think this is a great idea, I do think kids should not have to walk if it's more than a block away from home for safety reasons.
- I understand why this is being done, but with my sons situation in mind, moving him to a new school will have a very negative effect.
- I would like to see additional options that include Highview as a neighborhood elementary school.
- I'm all for it. We moved not even 5 mins away and my son is considered Amanda district and he is currently at student at Rosa Parks. 1817
 Woodlawn Avenue should be apart of Rosa Parks districT
- I'd like more information on what the district plans are for 6th grade band and orchestra next year.
- I'm confused by it, honestly. I do think that moving Central Academy into the Highview building is a good idea.
- In every single option provided, you have directly chosen to not list an option that DOESN'T include moving Central. Where's the option with redistricting all the other schools but leaving Central as it is as an application based program? Why was that not included? Did you actually listen to Central families and why we chose to apply to send out kids to that school? You mention Central isn't a neighborhood school but it is....it lives directly in 2 neighborhoods.
- It is a terrible idea to change these students' school. The majority of students in our school district are all victims of some sort (domestic violence, sexual abuse, mental abuse, etc.). They need their "normal" not a complete change. They have bonded and formed relationships with their teachers and schools. This could potentially be detrimental to these kids.
- It is my understanding that the Middletown Board of Education's directive
 was to close Highview and have the elementary school become K-6
 buildings keeping the 5th-grade students at their current school next
 year. If that is so why couldn't all the schools stay the same and close the

oldest building, the ELC? Then move the District Office to the second floor of Highview - saving the rent they are paying the City of Middletown and utilizing one of their buildings instead of having it be almost half empty. Highview was originally an elementary school so it shouldn't be hard to convert to the ELC's needs. Another thing that is missing from these options is the costs associated with each option. As a taxpayer in Middletown, I think the public should know the cost of each option and it should be a part of the Board's decision-making process - not the only thing to consider but it should be factored in and it should be public knowledge.

- It is very evident that Central Academy is the priority for this school board. Using Highview as a neighborhood school would be much more beneficial for many students in that area rather than sending them all the way to Miller Ridge or Rosa Parks. I thought the school board had the best interests of all of our children, not just one or two buildings. Sadly I was wrong, am disappointed, and can no longer support this board. All kids in Middletown deserve the best, not just one building. Do better for the Middies, MCSD is losing more supporters than ever because of decisions like this. Keep Central Academy open move the ELC to a building where it's closer to all neighborhoods. Moving the ELC to the Current Central Academy seems not helpful to those who aren't on the bus line or no transportation. Please this district needs to make better decision making
- It seems the move of students to Highview stopped at simply moving the students from Central Academy to Highview which in most plans lead to Highview being under utilized.

- Keep our teachers admins and paras together they've worked together the understand each others ways and we have some very good teams that shouldn't be split up
- Maybe we'll home school next year.
- My child attends Central Academy and that was my major concern. Central is more than a building. The faculty, staff, and students are what make it an authentic school community. My expectation is that our principal, faculty, staff, and students will move to the Highview building together so as to maintain Central's identity and mission, albeit with some improvements.
- My son is special-needs and he has been attending Creekview in the intellectual disabilities classroom for the last three and a half years. Our geographically assigned school is Wildwood, but he has attended Creekview because it has the specialized classroom that he needs for his education. We are in the Wildwood district based on geography and that does not change with any of the 4 options presented. I would like my son to be able to stay at Creekview so that he can have the continuity he needs with the same classroom and the same teachers that will help him progress in his education the best way possible. He is in fifth grade now so he only has one more year in elementary before he goes on to middle school. It would be very beneficial if he did not have any substantial changes and disruption for just one year. Thank you!
- My two children will be moving from Central Academy to Highview, under and of the four options. This will place them closer than one mile from school. Will there be bus routes available for students who live closer than one mile from Highview?
- None of these make sense. You say you're closing schools and now you
 aren't. When is the elc part of the school district. Oh wait the board wants
 to save central. The community wants neighborhood schools but yet
 bussing will be ramped up because you're taking highview away as a
 neighborhood school, why TO SAVE CENTRAL. This doggone democratic

- board needs to get their head out of their butts. This is what is best for them NOT our students. Do not come asking for a levy when you chose to be monetarily irresponsible to our school district.
- None of these plans include treating Central Academy like the rest of the elementary schools in the district, and if that hasn't already it should be considered an option. The school choice model was already taken from Rosa Parks, so Central getting to keep their model is biased and adds a fluctuating enrollment number that is an unnecessary x-factor in all the other schools' enrollment numbers. With redistricting it doesn't make sense to keep Central running buses all over the city to pick up kids instead of including them in these changes and having students able to be closer to a walkable elementary school. The enrollment numbers are inequitable in every option because of the special treatment that Central Academy is getting, when they could be moving to a bigger building and expanding the K-6 program they already run. There is no reason not to include them in these changes if enrollment is truly the main focus.
- On paper, program capacity may state one thing. I encourage those
 heading this process and making decisions to spend a day working and
 learning in the environment because the feeling (our daily reality) for most
 schools would not support grossly increasing the number of students in
 buildings. Adding the 6th graders back into the elementary building will
 already be a shift from the social-emotional shift for students to the
 logistical change in scheduling and resources. Consider making small shifts
 to allow for success for all students and buildings.

- The community of families that have children attending Central Academy are very much against this proposed relocation.
- The options presented don't make any sense. Your take a small neighborhood smack dab in the middle of the city and throwing it into the farthest possible schools.
- There are no good options as my kid will go from a walker to mayfield to a bus rider to Rosa or miller ridge. Be on a bus for an hr or more. I thought this was supposed to be making community schools but yet we are being moved miles away from our house when 4 schools are within walking distance. I wish the school board had kids in the school system and the two that do it would affect. Get your head out of your ass. This is absolutely RIDICULOUS. But let's make sure we save central that our tax money pays for but my kids aren't allowed to go there.
- These options move way to many children up and out of schools they are comfortable with and feel safe in. Option 4 moves the least amount of children

- We Believe The Children Should Remain In Thier Elementary School Until They Complete 6th Grade
- We sit directly in the middle of the boundaries. Would families have the
 option to choose which elementary school they attend because they are
 directly in the middle? I would like to go to the school that is less than a
 mile from our home.
- We understand that redistricting is a complex and emotional process, but we are concerned about the recent decision to forgo closing any buildings despite earlier guidance suggesting this was necessary to address declining enrollment and optimize building capacity. This change raises questions about its long-term financial impact, especially as it could lead to a deficit within five years. Why was this decision made, and how can we ensure we are making choices that secure a sustainable future for our district?
- We want to stay with Miller Ridge don't change the school my area attends

process?

- With a bigger campus, would enrollmen Options for central academy increase? Will students who are affected that have been at a school for 5+ years be "grandfathered" in to allow them to complete their schooling with peers they've had since KG days?
 - Worry more about the students and education rather than who is affected less. Take into consideration the class sizes. Go with a plan that helps to evenly distribute students amongst all schools! I feel a plan that helps with reduction in class sizes would give students a better teacher to student ratio making for a better learning environment with a possible increase in test scores!
